The Governor of Haryana hereby makes the following rules for regulating the guidelines for issuance of No Objection Certificate (NOC) of State Government for establishment of New Self-Finance Pharmacy Institution under Directorate of Technical Education, Haryana, namely:-

PART-I

GENERAL

 (1) These rules may be called the Guidelines for issuance of No Objection Certificate (NOC) of State Government for establishment of New Self-Finance Pharmacy Institution under Directorate of Technical Education, Haryana.

(2) They shall come into force on the date of their notification.

2. In these rules, unless context otherwise requires:-

(a) "Administrative Secretary" means Additional Chief Secretary/ Principal Secretary to Govt. of Haryana, Higher Education Department, as the case may be;

(b) "Government" means the Government of the State of Haryana in the

Administrative Department;

(c) "Head of Department" means the Director General, Technical

Education, Haryana;

- (d) "Degree/ Diploma level technical education" means such technical education to attain degree/ diploma or post diploma or post graduate courses:
- (e) "Institution/ college" means an institution/ university imparting degree or diploma level programme in pharmacy recognized by Pharmacy Council of India and affiliated with affiliation university or affiliation board, as the case may be;

(f) "PCI" means the Pharmacy Council of India established under

Pharmacy Act, 1948;

(g) "HSBTE" means Haryana State Board of Technical Education established under HSBTE Act, 2008;

PART-II

REQUIREMENTS FOR OPENING OF SELF FINANCE PHARMACY INSTITUTE/ COLLEGE

3. There will be the following three stages for opening of New Self Finance Pharmacy Institute/ College:-

(1) Submission of proposal in prescribed application form for establishment of new Self Finance Pharmacy Institute/ college alongwith the application fee and other necessary documents.

(2) Issuance of Letter of Intent (LOI) with conditions for compliance within a period of two years extendable for one more year.

(3) On checking compliance to the Letter of Intent, No Objection Certificate (NOC) will be issued by the State Government for opening of new Self Finance Pharmacy Institute/ college.

PART-III

SUBMISSION OF PROPOSAL

4. An application in prescribed application form as **Annexure-I** containing the proposal with a Detailed Project Report (DPR) shall be submitted to the department by the applicant alongwith a non-refundable fee of Rs. 50,000/- in favour of Joint Director, Haryana State Technical Education Society (HSTES), Technical Education Department, Bays No. 7-12, Sector-4, Panchkula (Haryana).

Submission of Proposal

- 5. The applicant can be a Non-Profit Organization like a Public Trust/ Society registered under Union or State Law or a Company registered under section 25 of the Companies Act, 1956. The society/ trust/ company must be in existence for at least three years. The registration documents of the sponsoring body alongwith membership and list of the office bearers with their address and objectives of the society/ trust/ company and terms & conditions governing them in the form of resolution of their, shall be submitted alongwith the application form.
- 6. The Detailed Project Report (DPR) submitted by the sponsoring body shall inter-alia contain the following information:-
 - (i) The background of the society/ trust/ company with reference to its experiences, if any, in promoting, managing and operating education institutions details of its promoters including their background, their activities in education spheres since its inception.
 - (ii) Development plan for the college spelling out its phase wise growth plan over the first 05 years in terms of academic programmes and increase in student intake.
 - (iii) Architectural Master Plan indicating the land use pattern with future projections.
- 7. The applicant shall submit the audit balance sheets of atleast three previous years and ways of means of financing the project.
- 8. The application shall be containing of all papers pertaining to land namely the registration deed / lease deed, CLU (if required), layout plan etc.
- 9. The application will be processed only if the applicant offers to run/ start new Pharmacy institute/ college for the courses of Pharmacy, as per the guidelines of concerned regulatory and apex body i.e. PCI, New Delhi.
- 10. All Applicants shall submit an Affidavit (as per Annexure-II) sworn before First Class Judicial Magistrate or Public Notary or an Oath Commissioner of Rs. 100/- Non-Judicial stamp paper/ e-stamp paper (Digitally Signed). In case of any false information, Directorate of Technical Education, Haryana shall invoke the provisions, civil and/or criminal as per the Regulations in place.

PART-IV

REQUIREMENT OF LAND AND OTHERS

11. No new Pharmacy Institute/ College can be open unless the sponsoring body i.e. society/ trust/ company, is in the possession on minimum land as required as per norms/ guidelines of the concerned regulatory body i.e. PCI. For the purpose of this clause, "possession" means possession either by way of ownership or as a lessee having perpetual irrevocable lease of at least 30 years or gift deed at the time of application. The land shall be exclusively earmarked for the proposed college.

12. The Promoter Trust/ Society/ Company shall have the Land as required and its Lawful possession with clear title in the name of the Promoter Trust/ Society/ Company on or before the date of submission of application.

Eligibility of the Sponsoring Body:

 a) A Society, registered under the Haryana Registration and Regulation of Societies Act, 2012 through the Chairman/ President/ Secretary of Society;

OR

b) A Trust, registered under the Indian Trust Act, 1882 as amended from

OR

c) A Company established under Section 8 of the Companies Act, 2013 or a Company registered under section 25 of the Companies Act, 1956;

OR

d) Central Government/ State Government/ UT registered with them.

A Registration document of the Society/ Trust/ Company under Section 8 13. indicating its members, objectives and Memorandum of Associations and Rules, duly attested/ certified by the concerned Authority.

Resolution by the Applicant organization for starting the new Institution and 14. allocation of Land/ Building/ Funds for the proposed activities as specified by

Certificate regarding Minority Status, if applicable at the time of application 15. issued by State Government indicating Minority Status of the Society/ Trust/

The Applicants cannot use the name of proposed institute in such a way that the 16. abbreviated form of name of the Institute becomes IIM/ IIT/ IISc/ NIT/ IISER/ IIIT/ IIEST/ NIPER/ PCI/ AICTE/ UGC/ MoE/ GoI. The Applicant shall also not use the word(s) Government/ India/ Indian/ National/ All India/ All India Council/ Commission in the name of the proposed institute giving an interpretation that it is a Government Institute while being a fully Private Institute and other names as prohibited under the Emblems and Names (Prevention of Improper Use) Act, 1950. Provided that the restrictions mentioned above shall not be applicable, if the proposed institute is established by the State Government or its name is approved by the Government.

- After approval of PCI and affiliation from examination body, the institution 24. will have to produce a Bank Guarantee Deposit of Rs. 50 lakhs in the bank accounts of the Society/ Trust before making admissions.
- Construct a minimum of 2500 square meters (25000 square feet) of covered 25. area in a separate campus/ building exclusive for the pharmacy institutions for academic and administrative purpose.

Adequate facilities for essential service (water, electricity, sewerage facilities 26.

and proper fitting in laboratories).

Separate common room for boys and girls, be provided on co-educational colleges.

- 29. Adequate accommodation for offices and proper staff room.
- 30. Well-equipped library, laboratories (as per requirement of concerned regulatory body i.e. PCI) and classrooms with adequate furniture etc.
- 31. Sports facilities should be provided subject to the availability / limitation of
- 32. The proposed institute/ college shall have MoU's/ agreements with a nearby hospitals/ nursing homes/ Pharmaceutical industries/ Pharmaceutical Companies for training & placement of students, if so required and mandatory condition for any course by the PCI as per their norms/ guidelines.
- 33. There shall be a whole time Principal in the College who shall have minimum qualifications prescribed by the State Government/ University/ PCI or any other regulatory body from time to time. Appointment of the academic staff having eligible qualifications shall also be made for teaching all courses, as prescribed by the State Government/ University/ PCI or any other regulating body.
- 34. The institution shall adhere to all the instructions, rules and regulations issued from time to time by the Government/ University/ PCI/ HSBTE and as per perspective plan of the State Government in this regard. The reservation policy for admission by State Government will be followed.
- 35. The institution shall charge only such fee and funds from the students as prescribed/ fixed by the State Fee Committee/ Affiliating University or Board/ State Government as well as for reserve categories as per State Government policy and shall not charge donations capitation fee etc. from the students.
- 36. The State Government reserves the right to refuse for grant of NOC on the grounds of vacant seats in the existing institutions.

PART-IV

ISSUANCE OF THE NO OBJECTION CERTIFICATE

- On receiving the report of the committee constituted to verify the compliance, the State Government, if satisfied may issue the No Objection Certificate (NOC) to start the Institute/ college on self-financing basis.
- 38. Any contravention of the prescribed norms/ conditions shall result in withdrawal of the No Objection Certificate (NOC), forfeiture of the endowment funds and legal penal action against the defaulting society/ trust/ company/ institutions including withdrawal of affiliation form the concerned University.
