The main objective of the scheme is to provide skill based training to unemployed youths in various skill sectors through Technical Institutes. The Training will be imparted by the Institute in off hours. For the academic year 2017-18, the AICTE portal is open for registration for AICTE approved Technical Institutes. Under the scheme, each institute can select maximum five sectors with 100 intakes per sector with a batch size of 25 number. The list of job roles along with minimum Qualification required is available on AICTE portal. The copy of letter received from MS, AICTE is enclosed for your ready reference.

The technical institutions/ polytechnics have to utilize their existing infrastructure for offering these courses in the off-college hours such that the unemployed youth enrolled for these courses shall acquire skills under the NSQF and find suitable placement/ self-employment. Under this initiatives AICTE will gave grant-in-aid to institutions as per the terms & conditions stipulated under the scheme. Copy of the scheme is available on AICTE website. All eligible institutions will have to register under the scheme online on AICTE portal.

All the Directors/ Principals of AICTE approved Technical Institutes in the State are requested to register under the scheme and impart the training to the willing youths of the area. The area of training/ sector can be selected based on the need of the area.
