

It was decided that the departments concerned be intimated that in pursuance of CS Notification No. 42/158/2016-5GSI dated 19.01.2018 reiterating the directions issued vide the earlier CS Notification No. 42/178/2008-5GSI dated 21.05.2009, the department does not recognize the degree qualifications obtained by the candidates in distance mode education.


It was also decided that the meeting of Equivalency committee be convened after every 3 (three) months.




