Notification under the section 3 of State Aadhaar Act, 2017

Subject: Notification for requirement of Aadhaar under Section 7 of the Central Aadhaar Act 2016 and Section -3 of State Aadhaar (Targeted Delivery of Financial and Other Subsidies, benefits and services) Act 2017 ("State Aadhaar Act") for Services/benefits provided by Technical Education Department, Haryana.

1. The use of Aadhaar as identifier for delivery of services/benefits/subsidies simplifies the Government delivery processes, brings in transparency and efficiency, and enables beneficiaries to get their entitlement directly to them in a convenient and hassle free manner. Aadhaar obviates the need for producing multiple documents to prove one's identity. The provisions of the State Aadhaar Act and Regulations under the Act have come into effect from 23rd March, 2017 in State of Haryana for the schemes funded out of **consolidated fund of State** and notifications to this effect have been published in the official Gazette.

The following services/schemes of Technical Education Department, Haryana are an expenditure from consolidated funds of State:-

- (i) Reimbursement of Tuition Fee under Scheduled Castes Sub Plan (SCSP) Scheme for SC Students.
- (ii) Reimbursement of State Transport of Facilities/ Train Pass under Scheduled Castes Sub Plan (SCSP) Scheme for SC Students.
- (iii) Supply of free books to SC Students.
- (iv) Merit Scholarship to deserving students studying in Government Polytechnics & Govt. Aided Polytechnics.

Accordingly, the Technical Education Department, Haryana in exercise of its powers under Section 3 of State Aadhaar Act hereby notifies the following:

- 1.1 Individuals desirous of availing services/benefits/subsidies under above said schemes are hereby required to furnish proof of possession of Aadhaar or undergo Aadhaar authentication.
- 1.2 An Individual desirous of availing services/benefits under above said schemes of the department, who is not yet enrolled for Aadhaar is hereby required to make application for Aadhaar enrolment by 31st October, 2017 in case he is entitled to obtain Aadhaar as per Aadhaar Act. Such individuals may visit any Aadhaar enrolment centre (list available at www.uidai.gov.in) to get enrolled for Aadhaar. The Government Polytechnic/ Processing Centre concerned are required to offer enrolment facilities for the beneficiaries who are not yet enrolled for Aadhaar. Therefore, in case there is no Aadhaar enrolment centres located nearby, Government Polytechnic/ Processing Centre concerned may provide enrolment facilities at convenient locations in coordination with the existing Registrars of UIDAI.
- 1.3 Till the time Aadhaar is assigned to the individual, the said reimbursement of fee/benefits shall be given to the eligible candidate/ student based on the following alternate and viable means of identification:-
 - (a) Bank photo passbook, and
 - (b) Aadhaar enrolment ID slip if he has enrolled, otherwise his voter ID card or Passport or driver license along with copy of his request made for Aadhaar enrolment as specified in para 2.2 below, and
 - (c) Self-undertaking that he is not availing benefit/services under some other ID number.

The above documents shall be checked by an officer of Government Polytechnic/Processing Centre, specifically designated by the department.
2. In order to provide convenient and hassle free services/benefit to beneficiaries, Technical Education Department through its disbursing centre/ processing centres shall make all the required arrangements including the following:
 - 2.1 Official information shall be given to all concerned Technical Institutes to make aware the applicants/beneficiaries regarding requirement of Aadhaar to receive the services/ benefits under the said schemes of the Department.
 - 2.2 In case, beneficiaries are not able to enroll due to non-availability of enrollment centres in the vicinity, the Government Polytechnics/ Processing Centres concerned are required to create enrolment facilities at convenient locations.
3. The notification shall take effect immediately.


