**CURBING THE MENACE OF RAGGING IN TECHNICAL
INSTITUTIONS/UNIVERSITIES INCLUDING DEEMED TO BE UNIVERSITIES
IMPARTING TECHNICAL EDUCATION**

It is brought to the notice of the institutions, students and other various stakeholders that ragging is a criminal offence and AICTE has framed regulations in order to prohibit, prevent and eliminate the scourge of ragging in technical institutions, Universities including Deemed to be Universities imparting technical education. The regulations have been notified vide F. / No. 37-3/Legal/AICTE, 2009 dated 1.7.2009 and are available on website www.aicte.india.org.

The above regulations are mandatory and shall apply to all the technical institutions, Universities including deemed to be Universities imparting technical education with effect from 1.7.2009. All institutions are required to take necessary steps for its implementation and ensure its strict compliance. The following preventive measures for Anti Ragging should also be strictly followed by institutions/universities /Deemed to be universities of Haryana:-

1. All Advertisement issue for admission by technical institution shall clearly mention that ragging is totally banned and any one found guilty of ragging and /or abetting ragging is liable to be punished.
2. The prospectus and other admission related document shall contain directions of Hon'ble Supreme Court and AICTE regulation for curbing the menace of ragging in AICTE approved technical Institutions and printed in the brochure of admission /instruction booklet for candidate
3. Affidavit with regard to non-indulgence in ragging activities must be obtained from every student and parent Guardian separately as per clause 5, sub clause 3 & 4 of the AICTE regulation as cited above. Another Affidavit must be obtained from students and parent/ Guardian alongwith the application of students while availing hostel accommodation as per Clause 5, Sub Clause 6 of AICTE regulation as cited above.
4. All Institutions should constitute the following:-
 - i) Anti-Ragging Committee as per clause 6 (a)
 - ii) Anti -Ragging squads as per clause 6 (c) and dedicated cadre of warden and
 - iii) Professional Counselors as per clause 5 sub clause II of AICTE regulation as cited above.
5. The institutions may erect suitable hoardings/bills boards/banners in prominent places within the campus /gates to exhort the students to prevent or not to indulge in ragging and also indicating there in the names of the official and their telephone numbers to be contacted in case of ragging
6. The institution shall also undertake other form of awareness campaign as it may consider appropriate to prevention of ragging.
7. All Institutions are requested to give wide publicity amongst the students before the start of the academic session. This may be constantly monitored during the entire period of the academic session.
8. Any violation of AICTE regulation as cited above, by AICTE approved institution or in case any institution fails to take adequate steps to prevent ragging or act in accordance with these regulations or fail to punish perpetrators or incident of ragging suitably, shall invite punitive action by State Govt. against erring institutions.
